2016

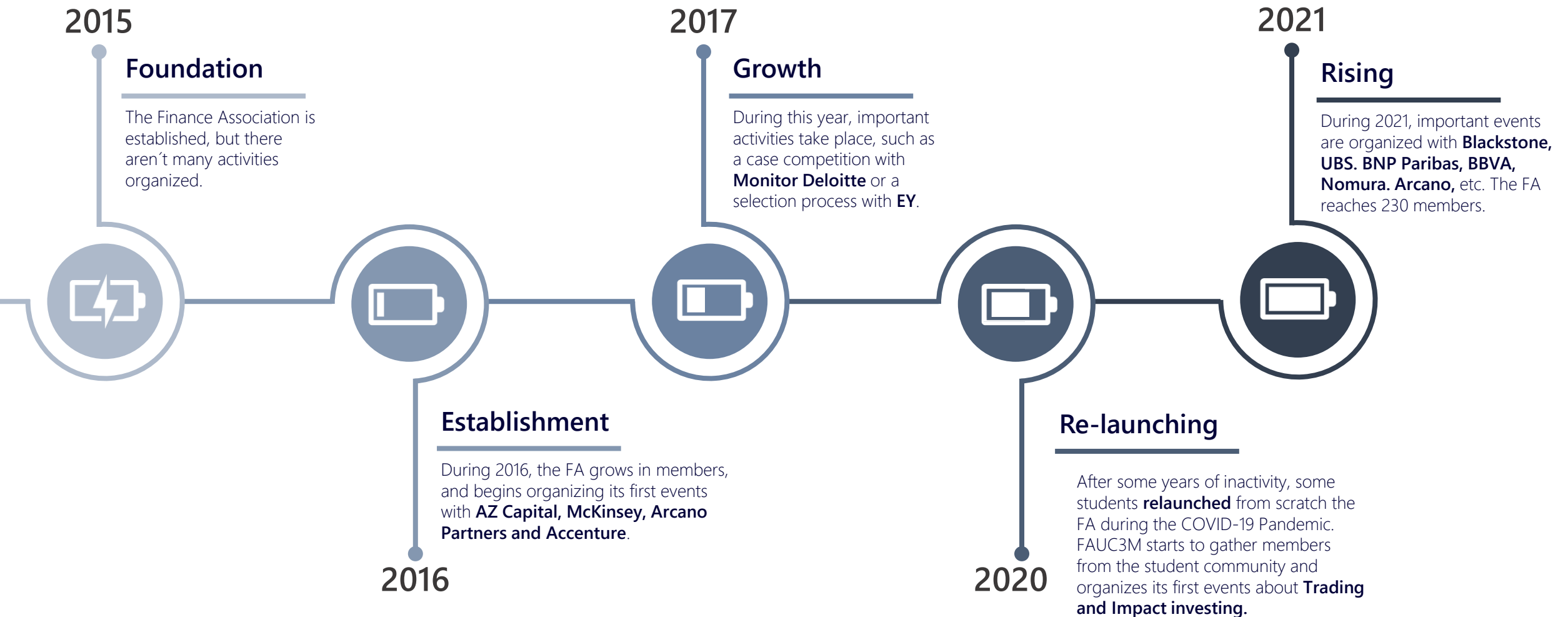
Establishment

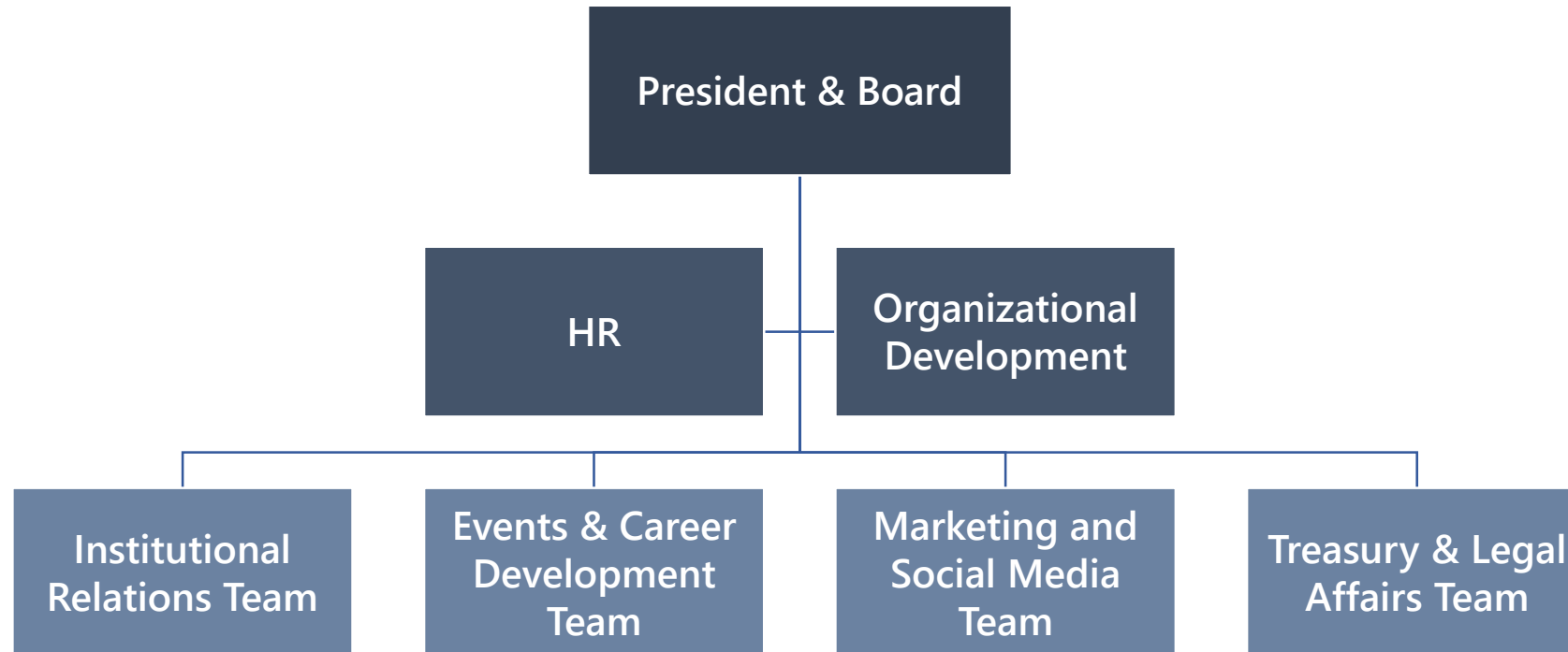

Case-competitions

- Case-competitions are a great opportunity to challenge our members into putting in practice everything they know about a certain topic (trading, investment banking...).
- **Virtual Stock Trading Competition 2020:** we gave 50 teams a virtual \$1M to invest during a whole month on listed companies, funds and ETFs in AMEX, Nasdaq, NYSE and OTC-BB. Although a virtual stock platform was used, all the values where real. Some teams really overperformed the overall markets, with returns of 40%+.
- It's planned to have a similar competition next year, and others about Value Investing and Investment Banking.



Activities & Events

Bootcamps

- Bootcamps are a series of intensive sessions with a common topic. The objective is to go deep into a complex financial subject and master it through various sessions.
- Examples of past bootcamps are the **Investing & Trading Bootcamp 2021** (about the different trading techniques and methods, with two trading and markets experts) and **Ethics in Finance** (a two-session webinar on the importance of morality in finance and how this is asked in the CFA Exam, with Finance Academy).
- We expect to hold the bootcamp **Getting Into Finance**, regarding the careers, selection processes, knowledge requirements, etc. in mid-September 2021.

Personal Development Workshops

- Personal Development Workshops are practical sessions oriented towards improving a specific topic such as **CVs and Cover Letters, how to network, how to nail an interview**, etc.

They have a **genuine interest in Finance and aspire to learn** from it



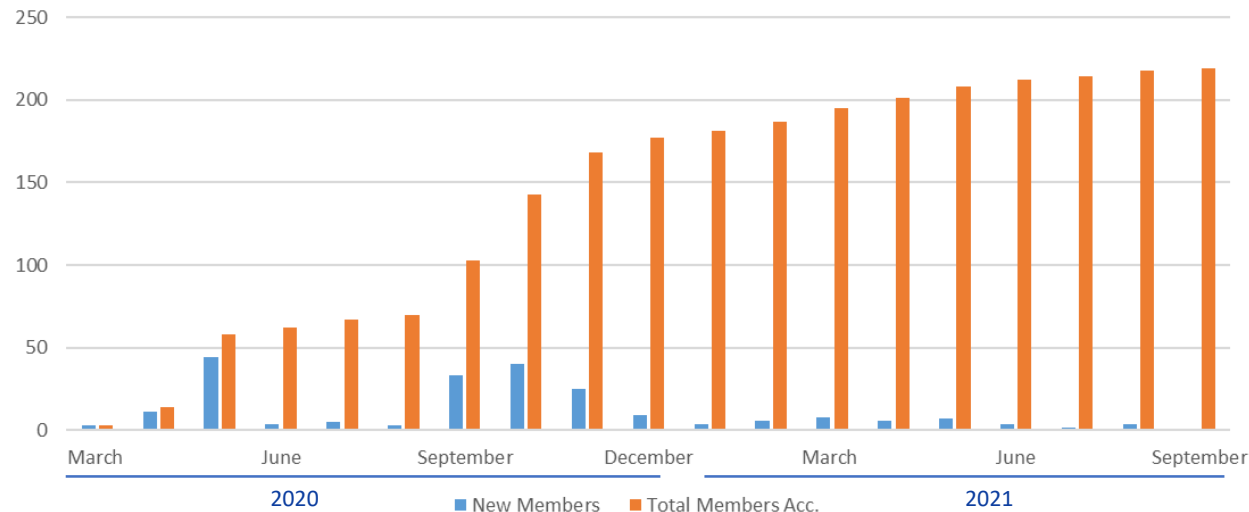

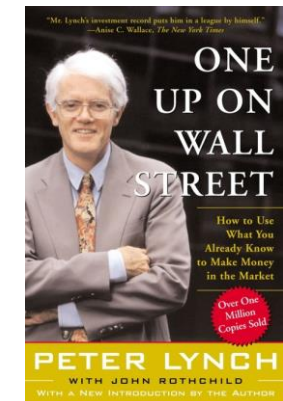
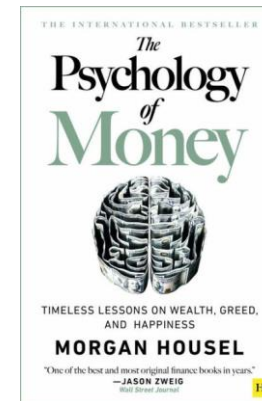
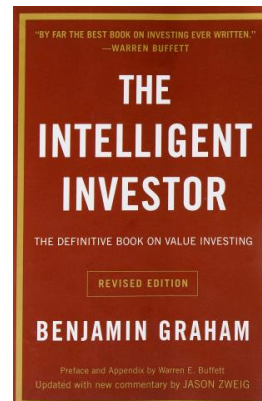
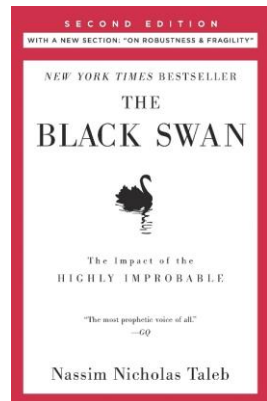
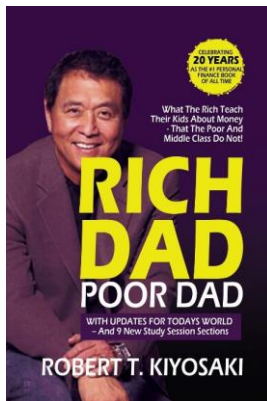
Resource Database

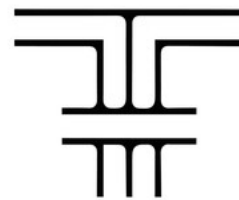
